The cost of running the Society is for ever increasing necessitating a reluctant rise in subscriptions to cover such items as postage, internet fees, Salaman Award Grants & general running costs etc. Membership fees have not been increased for 4 years and we have done everything possible to hold them at the current rate. A separate European membership rate has been included to reflect the high postal costs.
